ORDINANCE No. 183421

*Authorize a grant to Portland Farmers Market for \$15,000 to implement a waste reduction and diversion program at the Saturday PSU Market (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

- 1. The Portland Farmers Market is Portland's largest farmers market, attracting approximately 15,000 visitors to the South Park Blocks on Saturdays and connecting Portland residents and visitors with local, fresh and healthy food.
- 2. More than sixty 45-gallon bags of waste, including food scraps, plastic water bottles, paper plates, and packaging, are collected at each Saturday market event.
- 3. A waste audit conducted by the City of Portland's Office of Sustainable Development (now Bureau of Planning and Sustainability) in 2008 found that 90 percent of that waste could be diverted to recycling and composting streams.
- 4. The Portland Farmers Market will implement a "green market" Wastewise program to educate market visitors and vendors about waste reduction and diversion, and will set up a waste collection system to sort compostables and recyclables, with the goal of diverting 90 percent of the market's waste from landfills by year three of the program.
- 5. The FY 2009-2010 Adopted Budget included a Special Appropriation to the Portland Farmers Market to help launch this program.

NOW, THEREFORE, the Council directs:

- a. The Mayor, or a delegate in the Mayor's Office, is hereby authorized to execute a grant agreement for \$15,000 in one-time funds with Portland Farmers Market in conformance with the agreement attached to the original of this ordinance.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund when demand is present and approved by the proper authority.

Section 2. The Council declares that an emergency exists in order to begin immediate implementation of the Portland Farmers Market waste reduction program. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
