

ORDINANCE No. 183433

* Authorize an Intergovernmental Agreement with the Portland Development Commission for the Workforce Training & Hiring Program and Technical Assistance Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City has a compelling governmental interest in facilitating the full participation of all persons in opportunities generated by the City's public works contracts, as detailed in the Fair Contracting and Employment Strategy.
2. As a result, the City has signed an Intergovernmental Agreement with the Portland Development Commission to participate in the Workforce Training & Hiring Program that maximizes apprenticeship, employment, and training opportunities for minorities, women and economically disadvantaged workers and businesses in the construction field.
3. The Portland Development Commission has been a partner with the City of Portland Workforce Training & Hiring Program since 2001 and has expressed an interest in continuing this relationship for the 2009-10 fiscal year. To facilitate this and to further City/PDC cooperation in the areas of construction, nondiscrimination, and technical assistance services an updated Intergovernmental Agreement (IGA) has been developed.
4. The proposed IGA would permit the City to provide compliance services, data entry services, monthly participation reports, statistical reports, and outreach services on assigned PDC projects including projects located on the South Waterfront. In addition, contractors working on PDC projects will have access to a vast array of business development training offered through the Technical Assistance Program. In return, PDC will coordinate these programs with the City and provide funding to the City in the sum of \$250,000 for the 2009-10 fiscal year. This annual rate will be renegotiated annually.
5. The PDC has authorized its participation in the attached IGA.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute an Intergovernmental Agreement with the Portland Development Commission, and any future annual renewals for a period of not to exceed five years. The Agreement shall be in a form substantially similar to the proposed IGA that is attached as Exhibit A.
- b. The Bureau of Internal Business Services, Procurement Services is directed to carry out this IGA on behalf of the City.

Section 2. The Council declares that an emergency exists because the Portland Development Commission (PDC) has authorized execution of the IGA and it is important that PDC be able to begin full implementation of these programs and maintain progress with their disparity study with the City's assistance; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


