**1) Legislation Title:**

Apply for a grant from the State of Oregon Department of Environmental Quality for \$25,421.66 to support the recycling systems at Portland State University (PSU). (Ordinance)

**2) Purpose of the Proposed Legislation:**

To apply for a grant from the State of Oregon Department of environmental Quality for \$25,421.66 to Portland State University (PSU) to continue with the current bin consolidation project of pairing trash with recycling stations. To improve the effectiveness of each station, two frames holding a total of four educational signs are needed at every station, one sign each for commingled recycling, glass recycling, trash and waste reduction/sustainability programs information. The funds will be used to purchase 1,134 frames for 567 stations, holding a total of 2,268 signs.

### 4. History of Agenda Item/Background:

In April 2006, the City of Portland Council passed Resolution No. 36423 establishing goals for the solid waste and recycling system, including a 75% recycling rate by 2015.

The Department of Environmental Quality offers grants to local jurisdictions to encourage recycling and waste prevention. This grant will allow PSU to expand their sustainable practices. This will increase diversion that will positively affect our overall recycling goals.

### 5. Purpose of Agenda Item:

The ordinance will allow the Bureau of Planning and Sustainability to apply for a grant to pass \$25,421.66 of the Department of Environmental Quality grant funds to PSU for their project. There will be no financial impact for the City.

### 8 How Does This Relate to Current City Policies?

The grant funding available from DEQ allows businesses, community organizations and local government agencies to provide ongoing recycling and waste prevention programs and services to residents and businesses in Portland. These programs and services are critical to meeting higher recycling goals established by City Council in the adoption of the Portland Recycles! Plan in 2007-08. Achieving greater waste prevention and recycling is also a critical component of the Climate Action Plan recently adopted by Council.
