

**ORDINANCE No. 183459**

\*Accept a grant in the amount of \$17,435 from Oregon Military Department, Office of Emergency Management for the FY 2009 Citizen Corps Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. The Oregon Office of Emergency Management is providing financial assistance to the City of Portland through the Citizen Corps Program Grant. The grant provides funding for equipment, training, planning, exercise, and operational needs of Portland's Citizen Corps program.
2. Oregon Emergency Management has notified the City of Portland, Office of Emergency Management that it will receive an award for the FY 2009 CCP Grant in the amount of \$17,435.00.
3. The City of Portland, Office of Emergency Management will administer the grant for the Portland Citizen Corps.
4. There are no financial match requirements for the Citizen Corps Program Grant.
5. The City of Portland, Office of Emergency Management hereby requests acceptance of the FY 2009 CCP Grant award in the amount of \$17,435.00.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Oregon Emergency Management for the FY 2009 CCP Grant in the amount of \$17,435.00
- b. The FY 2009/2010 budget is hereby amended as follows:


