

## **ORDINANCE No. 183472**

Amend contract with Marshall Mediation for draft code revisions. (Ordinance; amend Contract No. 30000051)

The City of Portland ordains:

Section 1. The Council finds:

1. Marshall Mediation is currently under contract with the Portland Bureau of Transportation (PBOT) to perform project management, facilitation and draft code revisions.
2. PBOT needs to amend the contract to allow for work related drafting code revisions to Title 17 Public Improvement, Subsection 93 Street Renaming. Additional compensation not to exceed \$11,350.00 is also needed.
3. Work done to this point in time on street renaming process has been on time and in accordance with Contract No. 30000051.
4. The proper implementation of the City Code called for the first Historian Panel ever to be appointed under PCC 17.93 and a completed application was forwarded by the City Engineer to the panel for processing. The Historian Panel reviewed the application and conducted hearings as outlined in the City Code.
5. The Planning Commission received a recommendation from the Historian Panel and conducted a hearing as outlined in the City Code.
6. The public was encouraged to comment or testify at three town halls, and two public hearings. Written testimony has been encouraged and is part of the public record.
7. Subsequent work is needed as it relates to reviewing the application requirements and the street renaming process as outlined in the City Code. A report to council on the process requirements and a recommendation on possible code revisions was requested by Council.
8. This amendment is necessary to cover the work necessary to complete the review and recommendations for any amendments to the street renaming process.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and the Auditor are authorized to execute an amendment with Marshall Mediation, substantially in accordance with the amendment, Exhibit A, attached to an original of this ordinance, at a cost not to exceed \$11,350.00.
- b. The Commissioner-in-Charge and the Auditor are authorized to draw as deliver checks chargeable to the FY2009-2010 Budget Account 52100 SAP Cost Object 9TR000001411.


