

ORDINANCE No. 183477

* Accept a donation from Fireman's Fund Insurance Company, in cooperation with Toy N Joy Makers, with a value of \$7,500. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Fireman's Fund Insurance Company, in cooperation with Toy N Joy Makers, will pay \$7,500 towards the cost of purchasing the FLIR (Forward Looking Infrared Radar) System for use on the Portland Fire & Rescue (PF&R) Rescue Boat 17.
2. This payment will be made directly to the manufacturer of the FLIR system, on behalf of Portland Fire & Rescue.
3. The Fire Chief recommends that the Council accept the donation from Fireman's Fund Insurance Company and Toy N Joy Makers.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation of the payment of \$7,500 to the manufacturer of the FLIR System and thanks Fireman's Fund Insurance Company and Toy N Joy Makers for their donation.

Section 2. The Council declares that an emergency exists because it is important that this equipment be purchased as soon as possible; therefore, this ordinance shall be in force and effect from and after its passage by the Council.



