

ORDINANCE No. 183487

*Amend contract with Hoffman, Hart & Wagner LLP for outside legal counsel
(Ordinance; amend Contract No. 38137)

The City of Portland ordains:

Section 1. The Council finds:

1. The City required the services of outside legal counsel because of a conflict of interest in the matter of Sherri Carlson Sandau v John A Wood and City of Portland, Risk #G2006-0231-01RS; USDC #CV-07-632-PK.
2. The law firm of Hoffman, Hart & Wagner LLP, agreed to provide these services by Legal Services Agreement No. C38137 dated July 25, 2008.
3. Due to the matter being taken to trial, it is necessary to increase the amount of this contract.
4. To continue Counsel's work on this matter, it is necessary to extend the terms of the agreement until June 30, 2011.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to extend Legal Service Agreement No. C38137, dated July 25, 2008, to provide for representation by outside counsel in an additional amount of \$35,000, for a total not to exceed \$80,000.
- b. The terms of the agreement are extended to be in full force and effect through June 30, 2011.
- c. If applicable, the provisions of City Code Chapter 5.68 are waived.
- d. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.

Section 1. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner in the matter of Sandau v City; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
