**SIXTH AMENDMENT TO FUNDING AND PARTICIPATION AGREEMENT
FOR THE PORTLAND HARBOR NATURAL RESOURCE DAMAGE
ASSESSMENT & RESTORATION PROCESS**

I. PARTIES

This Funding and Participation Agreement (Agreement) is by and between the following Parties:

Natural Resource Trustees (Trustees)

- Confederated Tribes of the Grand Ronde Community of Oregon
- Confederated Tribes of Siletz Indians
- Confederated Tribes of the Umatilla Indian Reservation
- Confederated Tribes of the Warm Springs Reservation of Oregon
- Nez Perce Tribe
- Department of the Interior
- Oregon Department of Fish and Wildlife
- National Oceanic and Atmospheric Administration

Participating Party

- City of Portland

II. PURPOSE

The purpose of this Sixth Amendment is to:

- A) Continue funding for a cooperative assessment to facilitate resolution of any natural resource damage claims resulting from the releases of hazardous substances at the Portland Harbor Superfund Site;
- B) Authorize advance funding for the following Trustees: National Oceanic & Atmospheric Administration and U.S. Department of Interior. Advance funding for the following Trustees was authorized in the original Agreement: Confederated Tribes of the Grand Ronde Community Oregon, Confederated Tribes of Siletz Indians, Confederated Tribes of the Umatilla Indian Reservation, Confederated Tribes of the Warm Springs Reservation of Oregon, Nez Perce Tribe, and the Department of Fish and Wildlife

III. EFFECT

All applicable provisions of the Funding and Participation Agreement shall remain in full force and effect pursuant to Sections XII and XVII therein and this Sixth Amendment shall be effective when signed by one Trustee and the Participating Party.

IV. FUNDING

The Participating Party shall fund the cooperative assessment activities set out in Attachment A to this Amendment. The funding level will be \$ 360,000.

V. SIGNATURES

The undersigned representative of each Party certifies that he or she is fully authorized by the Party whom he or she represents to enter on this Fifth Amendment and to bind that Party to it.
