## **ORDINANCE No.** 183497

\* Accept a grant in the amount of \$10,000 from Oregon Parks and Recreation Department, Heritage Programs for historic preservation work at Mount Tabor Gatehouse No. 1 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. Portland Water Bureau applied to the State of Oregon, acting by and through Oregon Parks and Recreation Department, Heritage Programs for a grant in the amount of \$10,000 for historic preservation work at Mount Tabor Gatehouse No. 1 on October 13, 2009.
- 2. State of Oregon, acting by and through Oregon Parks and Recreation Department, Heritage Programs has notified the City of Portland that it will award a grant for historic preservation work at Mount Tabor Gatehouse No. 1 to the Portland Water Bureau in the amount of \$10,000.

NOW THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the State of Oregon, acting by and through Oregon Parks and Recreation Department, Heritage Programs for historic preservation work at Mount Tabor Gatehouse No. 1 in the amount of \$10,000.
- b. The FY 2009-10 budget is hereby amended as follows: <u>Grant Funds</u> Fund 217006 Business Area – WA00 Bureau Program Expenses - \$10,000

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore this ordinance shall be in full force and effect from and after its passage by Council.
