Authorize an Intergovernmental Grant Agreement with Metro to receive sponsorship for Bureau of Planning and Sustainability ReTHINK educational series and Build It Green! Home Tour in the amount of \$8,000 in FY 09-10 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Planning and Sustainability green building program has implemented the ReTHINK educational series and the Build It Green! Tour of Homes and Information Fair to support green building activities in Portland.
- 2. The green building program supplies technical assistance, educational programs, tours and grants to commercial and residential projects in Portland.
- 3. Metro proposes to provide financial support for these programs because they are consistent with its Solid Waste and Recycling objectives in the area of construction and demolition debris recycling programs and the construction and demolition waste reduction initiatives.
- 4. The City of Portland is eligible to receive \$8,000 in FY 09-10 to support the ReTHINK educational series and the Build It Green! Home Tour.

NOW THEREFORE, The Council directs:

- a. The Mayor is authorized to execute an agreement with Metro for the purpose described in Section 1, in the amount of \$8,000.
- b. The FY 2009/2010 budget is hereby amended as follows:
