## ORDINANCE No. 183506

\*Pay property damage claim of George Simpson (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. George Simpson has filed a property damage claim against the City for damages suffered in a motor vehicle accident involving the Water Bureau on July 9, 2009.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
- 3. Risk Management Services recommends the claim be compromised for the total sum of \$8,978.63, subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management Services has previously advanced \$500.00 to Mr. Simpson for his insurance deductible, and paid \$1,149.77 to Enterprise Rent a Car for rental charges. Geico Insurance seeks reimbursement of \$7,328.86 for vehicle repair costs.

## NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$7,328.86 made payable to Geico Insurance.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
