## ORDINANCE No. 183532

\* Accept a grant in the amount of \$136,800 from the Federal Emergency Management Agency Assistance to Firefighters Grant Program to purchase thermal imaging cameras. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. Portland Fire & Rescue (PF&R) applied to the Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grant Program (AFG) for a grant in the amount of \$182,400 to purchase thermal imaging cameras on May 20, 2009.
- 2. FEMA has notified the City of Portland that it will award a grant for the purchase of thermal imaging cameras to PF&R in the amount of \$136,800.
- 3. This grant requires a \$34,200 match, which will be funded with FY 2009-2010 PF&R operations budget.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Federal Emergency Management Agency for the purchase of thermal imaging cameras in the amount of \$136,800.
- b. The FY 2009/2010 budget is hereby amended as follows:

<u>GRANTS FUND</u> Fund 217001 Business Area – FR00 Bureau Program Expenses – 534000 = \$136,800

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
