ORDINANCE No.

Accept donation of solar powered compacting trash cans from the Lloyd District Transportation Management Association. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland contracts with private solid waste haulers to collect garbage from public trash cans located within specified business districts within Portland.
- 2. Use of solar powered compacting trash cans may require fewer collection stops, thus reducing emissions from collection vehicles, including greenhouse gases.
- 3. Availability of public recycling containers will likely result in more materials being recycled instead of being disposed of as garbage and will increase overall public awareness of recycling.
- 4. The Lloyd District Transportation Management Association has offered to donate solar powered compacting trash cans and, potentially, recycling units to the City. The City is interested in the possible efficiencies offered by the solar powered compacting trash cans, but has no budget resources available to acquire such containers.
- 5. As provided under PCC 5.36.090.A, gifts which may obligate the City in amounts exceeding \$250 require prior approval by the City Council.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a donation of solar powered compacting trash cans and recycling units from the Lloyd District Transportation Management Association.
- b. The Director of Planning and Sustainability is hereby authorized to enter into the attached Memorandum of Understanding with the Lloyd District Transportation Management Association.
