Accept donation of solar powered compacting trash cans from the Lloyd District Transportation Management Association (Ordinance)

### 2) Purpose of the Proposed Legislation:

The purpose of this ordinance is to accept the donation of solar powered compacting trash cans to replace existing garbage cans in the Lloyd TMA area.

## 3) Revenue:

The donated containers have a higher standard maintenance and replacement cost than the existing garbage cans. However, the solar cans need to be emptied 25% as frequently, which should save the City in collection costs. Overall, there should be negligible financial impact to the City.
