

ORDINANCE No. 183568

*Revise ordinance for settlement of property damage claim of George Simpson to correct payee information. (Ordinance: amend Ordinance No. 183506)

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 183506 passed City Council on February 3, 2010 resolving the property damage claim of George Simpson, whose vehicle was damaged in a collision with a Water Bureau driver on July 9, 2009.
2. Risk Management Services detailed total property damages in the amount of \$8,978.63, which included \$500 for Mr. Simpson's insurance deductible, \$1,149.77 to Enterprise Rent a Car, and \$7,328.86 to reimburse Mr. Simpson's auto insurance company. Ordinance No. 183506 directed the Auditor to issue a check in the amount of \$7,328.86 payable to Geico Insurance.
3. City Council passed Ordinance No. 183506, but the ordinance contained an error which misstated the name of Mr. Simpson's insurance carrier, identifying it as Geico Insurance.
4. The correct payee for the \$7,328.86 check should be State Farm Insurance.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 183506, Section 1.a of the Council directives is amended to read as follows:

The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$7,328.86 made payable to State Farm Insurance.

- b. All other terms and provisions of Ordinance No. 183506 remain the same and are not affected by this ordinance.

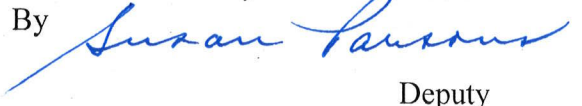

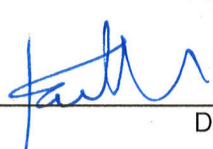
