

**ORDINANCE NO: 183585**

\*Revise ordinance for revocable permit granted to Paddy's Bar and Grill to correct insurance information (Ordinance; amend Ordinance No. 183546)

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 183546 passed Council on February 10, 2010 granting a revocable permit to Paddys Bar and Grill to close SW Yamhill St between SW 1<sup>st</sup> Ave and SW Naito Parkway from 12:01 a.m. on March 17, 2010 until 9:00 a.m. March 18, 2010 to host their annual St. Patrick's Day celebration to benefit the Children's Cancer Association.
2. Portland Bureau of Transportation submitted an ordinance requesting the street closure and permission for the applicant to possess, use and sell food and alcoholic beverages in the area covered by the closure, through Ordinance No. 183546.
3. The ordinance was submitted as a consent agenda item on the February 10, 2010 hearing and passed through Council vote.
4. The ordinance passed, but included an error on Section 1 point 6 regarding the insurance certificate submitted.
5. The corrected point 6. should read as follows: Applicant has provided an Insurance Certificate, which has been approved by the City Attorney, with limits of coverage that will meet the minimum requirements for liability of a public body as set forth in OR 30.260 through 30.000 which names the City, it's officers, agents and employees as an additional insured.

NOW, THEREFORE, The Council directs that:

- a. Ordinance No. 183546, Section 1.6 of the Council directives is amended to read as follows:


Applicant has provided an Insurance Certificate, which has been approved by the City Attorney, with limits of coverage that will meet the minimum requirements for liability of a public body as set forth in OR 30.260 through 30.000 which names the City, it's officers, agents and employees as an additional insured.
- b. All other terms and provisions of Ordinance No. 183546 remain the same and are not affected by this amendment.

Section 2. The Council declares that an emergency exists because delay in the enactment of this Ordinance will result in an unnecessary hardship on the part of the applicant as to the status of the requested permit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
