This ordinance authorizes the acquisition of a1.2 acre property on SE 136th that will be added to the adjacent Gates Park.

The purchase price will be paid out of SDC Acquisition Funds. Stabilization costs will be paid out of SDC funds. Ongoing O&M will be requested through the budget process.
