

ORDINANCE No. 183593

* Accept a grant agreement in the amount of \$25,000 from the Mt. Hood Cable Regulatory Commission Cable Access Grant Programs for The Gateway Center for Domestic Violence Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. As a result of the significant local commitment to the establishment of the Gateway Center for Domestic Violence Services the City of Portland was invited to participate in a special grant funding round by the Mt. Hood Cable Regulatory Commission; and
2. On February 3, 2010 the City of Portland applied for a grant in the amount of \$25,000 to support the purchase of video conferencing equipment that will allow restraining order applications to be processed at the Gateway Center for Domestic Violence Services; and
3. The Mt. Hood Cable Regulatory Commission has notified the City of Portland that it will award a grant for The Gateway Center for Domestic Violence Services to the City of Portland in the amount of \$25,000.

NOW THEREFORE, The Council directs:

- a. The Commissioner of Public Affairs is hereby authorized to accept on behalf of the City of Portland a grant from the Mt. Hood Cable Regulatory Commission in the amount of \$25,000 in a form substantially in conformance with Exhibit A.
- b. The FY 2009/2010 budget is hereby amended as follows:

GRANTS FUND

Fund 217007

Business Area – PAOO

Bureau Program Expenses– 534000 = \$ 25,000

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by council.


