

ORDINANCE No. 183621

*Accept a periodic review grant in the amount of \$83,000 from the Oregon Department of Land Conservation and Development (Ordinance).

The City of Portland Ordains:

Section 1. The Council finds:

1. On August 11, 2008 the Portland City Council transmitted a periodic review work program to the Oregon Department of Land Conservation and Development (DLCD) to update the economic development, housing, public facilities, transportation, and urbanization elements of the City's Comprehensive Plan.
2. On September 1, 2009 DLCD announced the availability of a grant program, stating that the highest priority would be funding of approved periodic review work tasks.
3. On September 30, 2009 the Director of DLCD approved Portland's periodic review work program. This approval made the Portland Bureau of Planning and Sustainability eligible for a periodic review grant.
4. On October 21, 2009 the Portland City Council, with Ordinance No. 183249, authorized the Mayor to apply to DLCD for a Periodic Review Grant in the amount of \$83,000 for the State Fiscal Biennium of July 1, 2009 to June 30, 2011.
5. On October 29, 2009 the Portland Bureau of Planning and Sustainability submitted the authorized grant application to the DLCD.
6. On December 31, 2009 the DLCD informed the Mayor by letter that the City had been awarded \$83,000 for periodic review, and that funded work could begin pending the signing of a forthcoming grant agreement to be prepared by the by the DLCD. The notice of award letter is attached as Exhibit A, which is made part of this ordinance by this reference.
7. On March 4, 2010 the DLCD provided the City the necessary grant agreement, agreement attachments, and explanatory letter. The explanatory letter is attached as Exhibit B; the grant agreement is attached as Exhibit C; and the grant agreement attachments are attached as Exhibit D. Exhibits B, C, and D are made a part of this ordinance by this reverence.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a Periodic Review Grant in the amount of \$83,000 from the DLCD, and sign the grant contract agreement attached as Exhibit C.

The City Fiscal Year 2009/2010 Budget is amended as follows:

Section 2. The Council declares an emergency exists because a delay would unnecessarily restrict the City's ability to recover costs from activities already underway that are authorized expenditures under the grant, and because the granting agency requires City acceptance with 30-days of offer; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


