**RESOLUTION No. 36773**

Appoint Lindsey Detweiler to the Citizen Review Committee advisory body of the Auditor's Independent Police Review Division (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review Division (IPR) and the Citizen Review Committee (CRC);

WHEREAS, a nine-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review Division;

WHEREAS, the committee has one vacant term that expires on December 31, 2011;

WHEREAS, from 21 applicants, one applicant was recommended by a Selection Committee consisting of three CRC representatives, two members of the community, and the Director of the Independent Police Review Division;

WHEREAS, the Auditor nominated the one recommended member to Council;

NOW, THEREFORE, BE IT RESOLVED, that the Council for the City of Portland, Oregon appoints to the Citizen Review Committee new CRC member Lindsey Detweiler for the term that began January 1, 2010 and expires December 31, 2011.


