1) Legislation Title:

*Authorize application to the United States Department of Justice, Office of Justice Programs, National Institute of Justice for a grant in the amount of \$280,453 for the FY 2010 Solving Cold Cases with DNA grant program (Ordinance)

2) Purpose of the Proposed Legislation:

Application for grant funding from the United States Department of Justice (USDOJ), Office of Justice Programs (OJP), National Institute of Justice (NIJ) for solving Cold Cases with DNA. The application requests funding for four limited-term part-time investigators, one 0.5 FTE limited-term public safety aide, one limited term, part-time community outreach coordinator, 1.0 FTE State Crime Lab Forensic Scientist I dedicated to reviewing PPB Cold Case Homicides and crime lab program supplies not to exceed the grant application request of \$280,453.

3) Revenue:

Will this legislation generate or reduce current or future revenue coming to the City? If so, by how much? If new revenue is generated please identify the source.

The legislation will provide operational revenue for the City of Portland Police Bureau. The revenue source is the USDOJ, OJP NIJ. The grant period is November 1, 2010, through April 30, 2012.

4) Expense:

The USDOJ will not reimburse the City for TriMet payroll taxes and TRIP benefits. The expenses will be funded with existing Police Bureau FY11 - FY13 General Fund appropriation within the Detective Division. No match is required for this grant.

Rehire four limited term, part-time investigators classified as Senior Administrative Specialists; rehire 0.5 FTE limited term, part-time public safety aide and rehire limited term, part-time community outreach coordinator

The investigators will work for approximately 14 months, until they complete the review of the remaining cold case homicides or the funding cap is met. The public safety aide will work for the duration of the grant period, 18 months. The community outreach coordinator will work only 480 hours during the grant period.
