Section 1. The Council finds:

1. Samuel Galbreath and the Macadam Bay Homeowners Association have one (1) high-pressure Standard Floto-Pump and two (2) 100-foot sections of 1 ½ inch unlined nylon jacketed hose that they would like to donate to Portland Fire & Rescue.
2. The equipment has an approximate value of \$1,000.

NOW, THEREFORE, the Council directs:


- a. The City Council accepts the donation from Samuel Galbreath and the Macadam Bay Homeowners Association thanks them for their donation.


