7. BACKGROUND/ANALYSIS

Portland Urban Area (PUA) emergency managers recognize that the function of resource management is critical to the readiness and resilience of the region. Significant challenges in resource management came to light with the region's response to the December 2007 windstorm and flood event. The process for ordering and tracking resources was confusing and inefficient. Incident managers were forced to use informal and ad-hoc methods to get resources. In recognition of this critical need, the POC Group authorized funding for a Portland Urban Area Resource Management Assessment and Plan project and authorized the creation of the Urban Area Resource Management Committee.

The amended contract with TechLaw Inc. is to complete specific research into incident organizations that can facilitate regional resource sharing and processes and systems for regional resource management; facilitate the input and involvement of at least two specialized focus group (the 'strategy' and 'logisticians' focus groups) in the development of the plan for an additional compensation not to exceed \$125,000.

8. FINANCIAL IMPACT

There are no matching funds required from the UASI counties or Portland. The UASI Resource Management Assessment and Plan is currently funded through the UASI FY 2007 Grant award. The amendment and additional scope of work will be funded through the UASI FY 2008 Grant award.
