ORDINANCE No. 183661

*Amend template to authorize the Director of the Bureau of Planning and Sustainability to enter into Intergovernmental Agreements with the Portland Development Commission to provide professional, technical and expert services (Ordinance; amend Ordinance No. 181358)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Planning and Sustainability (BPS) in partnership with the Portland Development Commission (PDC) is responsible for creating long-range plans and strategies that help the City of Portland manage growth and promote livability, sustainability and preservation of Portland's heritage within the designated urban renewal districts.
- 2. BPS and PDC, under their respective charter authorities, are authorized to enter into cooperative agreements for the improvement of the community.
- 3. As the City's bureau responsible for long-range planning and initiatives to promote a sustainable economic future, BPS will help apply comprehensive planning goals to develop action plans for various urban renewal districts.
- 4. BPS will develop these projects along with PDC with open public involvement processes and work with Purchasing to promote diversity efforts in contracting any work. BPS will perform this work by providing a high level of service to the community and seek efficiencies in projects through interbureau collaboration.
- 5. BPS and PDC have developed a single- and multi-year intergovernmental agreement template for professional, technical, and expert services for long-range planning and strategizing to be used for each project agreement.
- 6. BPS and PDC have improved the Intergovernmental Agreement template by revising and updating terms, including those related to Business and Workforce Equity and the Percent for Art Program.
- 7. On October 17, 2007, by Ordinance No. 181358, Council previously delegated authority to execute Intergovernmental Agreements with PDC to the Director of the Bureau of Planning. On January 7, 2009, by Ordinance No. 182464, Council merged the Bureau of Planning with the Office of Sustainable Development to create the Bureau of Planning and Sustainability.
- 8. The purpose of this Ordinance is to authorize the Director of the Bureau of Planning and Sustainability to enter IGAs with PDC using the improved IGA template.

NOW, THEREFORE, the Council directs:

a. The Council hereby delegates to the Director of Planning and Sustainability and the Director of the Portland Development Commission the authority to execute single- and multi-year Intergovernmental Agreements between the Bureau of Planning and Sustainability and the Portland Development Commission, to provide professional, technical, and expert services for long-range planning and strategizing consistent with comprehensive goals for the community, similar in form to the agreement attached as Exhibit A to the original of this Ordinance, and by this reference made a part hereof, with approval of the City Attorney.

Section 2. The Council declares that an emergency exists to allow projects to commence or continue without delay and new IGAs to be written with the updated language related to Business and Workforce Equity and the Percent for Art Program; therefore this ordinance shall be in full force and effect from and after its passage by the Council.
