**2) Purpose of the Proposed Legislation:** General housekeeping changes referencing Title 17 Code language regarding City Engineer authority for posting sidewalk repair notices, and a reduction in permit fees, in both Title 17 and Portland Policy Documents. Council has previously approved the ability to charge fees for posted sidewalk repairs and other permits through other ordinances and as part of Approved budgets. This is a housekeeping measure to eliminate the inequity for some property owners who might be charged the incorrect sidewalk repair fee.
