

ORDINANCE No. 183668

* Authorize payment of \$10,000 to Portland Public Schools for installation of playground equipment at Brooklyn School Park (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:


1. Portland Public Schools (PPS) owns the property on lots bordered by S.E. 14th and S.E. 16th Avenues and S.E. Bush Street and S.E. Center Street and operates Winterhaven School, located at 3830 S.E. 14th Avenue. Immediately adjacent to the school is Brooklyn School Park, which is owned by PPS but managed as a park by the City.
2. In 2007, the majority of the playground equipment was removed from the park due to safety reasons. PPS was able to replace only a portion of the equipment, leaving the playground inadequate for the park which is heavily used by both community members and school children.
3. Neighbors of Brooklyn School Park and parents of children at Winterhaven School raised \$30,000 to purchase playground equipment for the park. Total cost of the project is approximately \$70,000.
4. Winterhaven School has agreed to provide construction management to install the equipment. The city has agreed to pay \$10,000 as a contribution to the project.
5. PPS & PPR have agreed to the terms of the construction in a non-park use permit.

NOW, THEREFORE, The Council Directs:

- a. PPS will pay \$10,000 for installation, construction management and review related to installation of new playground equipment at Brooklyn School Park on receipt of an invoice from PPS.

Section 2. The Council declares that an emergency exists because further delay in installing the playground equipment will deprive area children of a safe place to play; therefore this Ordinance shall be in force and effect from and after its passage by Council.
