

ORDINANCE No. 183669

- * Accept a supplemental grant in the amount of \$321,221 from the Department of Homeland Security for Portland Fire & Rescue related to the City's Metropolitan Medical Response System. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. The Department of Homeland Security has notified the City of Portland that it will award a supplemental grant for the Metropolitan Medical Response System (MMRS) to Portland Fire & Rescue (PF&R) in the amount of \$321,221; and
2. No matching funds are required.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Department of Homeland Security for the Metropolitan Medical Response System in the amount of \$321,221.
- b. The FY 2009/2010 budget is hereby amended as follows:

Bureau Program Expenses– \$267,221

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
