ORDINANCE No. 183671

*Pay Claim of Nicole Whitley. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Nicole Whitley, through her attorney, Katelyn Oldham, has filed a lawsuit against the City related to her employment with the Portland Police Bureau.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
- 3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$170,000.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver checks to Nicole Whitley in the amount of \$23, 691.20 less the usual payroll withholding and deductions and to Nicole Whitley and Katelyn Oldham, Attorney at Law in the amount of \$146,308.80.
- b. Risk Management Services will execute a payment authorizations in the amounts set forth in sub-paragraph (a) above.
- Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
