#### ORDINANCE No.

\*Accept Historic Preservation Fund Grant of \$17,000 to support the City's historic resources program (Ordinance)

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 183541, the Bureau of Planning and Sustainability applied to the State Historic Preservation Office on February 19, 2010 for a grant in the amount of \$17,000 to support the City's historic resources program; and
- 2. The State Historic Preservation Office has notified the City of Portland that it will award a Historic Preservation Fund Grant in the amount of \$17,000 to the Bureau of Planning and Sustainability. The grant will support the City's historic resources program.
- 3. Local match in the amount of \$17,000 will be provided by funds from the Historic Preservation program, SAP cost center PNCP000001. The match will be in the form of salary, benefits and materials.

### NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the State Historic Preservation Office for the Historic Preservation Fund Grant in the amount of \$17,000, in accordance with the form attached as Exhibit A, Grant Agreement 2010 for Certified Local Government Grant # OR-10-15.
- b. The FY 2009-10 budget is hereby amended as follows:
