#### 7. BACKGROUND/ANALYSIS

**Introduction and History** – The proposed Ordinance authorizes the City to enter into a contract with K&L Gates, LLP (the "Contractor") to provide bond counsel services. The amount of the contract is \$1.5 million and the term would extend for approximately three years until August 31, 2013.

The selection of the Contractor was the result of a competitive RFP process in which three firms submitted proposals. Proposals were evaluated by a team consisting of staff from the Debt Management program, other City bureaus that utilize bond counsel services, the City Attorney's office, and an outside party.
