

**ORDINANCE No. 183709**

\* Authorize Intergovernmental Agreement with the Parkrose School District related to sport field improvements. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City and the School District are authorized to enter into intergovernmental agreements with other local governments.
2. The City and the School District recognize that providing access to suitable sports fields for East Portland residents is a valuable component of overall neighborhood livability.
3. The Coalition for a Livable Future's Regional Equity Atlas finds that the Parkrose neighborhood includes above average numbers of people living in poverty and people of color, with inequitable parkland access.
4. Soccer is a sport that is widely loved and played across cultures and has the ability to bring together families of different races, cultures and ethnicities.
5. The Youth Bill of Rights, accepted by the Portland City Council in Resolution No. 36432 on August 16, 2006, states that extra-curricular activities and facilities to support those activities, including athletics, should be made available to all students. Children and youth should have access to athletics and other activities regardless of their family's inability to pay, to promote health and wellness for youth.
6. It is in the mutual interest of the School District and the City to partner in improving soccer facilities open to the public at Parkrose High School.
7. The City Council appropriated funds for this purpose in the Fiscal Year 2009-10 Special Appropriation Approved Budget.
8. The Intergovernmental Agreement between the City and the Parkrose School District is attached as Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Utilities is authorized to enter into an Intergovernmental Agreement with the Parkrose School District, as outlined in a form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$100,000.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2009-10 Special Appropriation Budget.

Section 2. The Council declares that an emergency exists because any delay in providing funds to the Parkrose School District would be harmful to the public interest; therefore, this ordinance shall be in full force and effect from and after its passage.
