

ORDINANCE No. 183716

*Pay claim of Marsha Anderson. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Marsha Anderson, a former purchasing assistant, filed an unlawful employment practices complaint with the State Bureau of Labor and Industries (BOLI).
2. BOLI's investigator found substantial evidence on which to proceed with a hearing to determine Ms. Anderson's rights under ORS 659A.112 and 659A.183.
3. Rather than proceed with a hearing, BOLI mediated a settlement between the parties which requires City Council approval.
4. Risk Management Services recommends the claim be compromised for the total sum of \$8,000.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$8,000.00 made payable to Marsha Anderson.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.

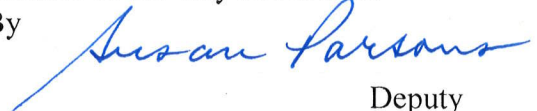
