## ORDINANCE No.

\*Amend contract administered by the Bureau of Human Resources, Benefits and Wellness Office with BenefitHelp Solutions for Flexible Spending Account Administration effective July 1, 2009 through June 30, 2014 (Ordinance; amend Contract No. 30000523)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Office of Management and Finance, Bureau of Human Resources requires the continuing provision of employee health and welfare administration as provided under PCC Section 5.33.220.
  - a. In order to maintain employee health and welfare administrative service agreements it is deemed appropriate and necessary to reflect the appropriate not to exceed contract amount as calculated based upon anticpated future employee pre-tax elections under the City's Flexible Spending accounts.

The Health Fund Budgets for FY 2010-11 include appropriations in support of the benefit related contracts listed above.

## NOW THEREFORE, the Council directs:

- a. The Mayor or the Director of Human Resources is hereby authorized to execute the contract amendments and any subsequent renewals during the term of the contracts, substantially similar hereto as Exhibits A-C attached.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants not to exceed the amounts listed in each independent contract.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in providing benefits to plan participants; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
