

**ORDINANCE No. 183738**

Amend contract with Aliquant Corporation for web-based benefit enrollment and related IT administrative software system services to extend the termination date of the contract from June 30, 2010, to June 30, 2013 (Ordinance; amend Contract No. 35136)

The City of Portland ordains:

Section 1. The Council finds:

1. The Office of Management and Finance, Bureau of Human Resources requires the continuing provision of employee health and welfare administration as provided under PCC Section 5.33.220.
2. In order to maintain employee health and welfare administrative and enrollment services it is deemed appropriate and necessary to implement the following contract amendment effective July 1, 2010 as attached in the following Exhibit:
  - a. Aliquant Corporation for benefit administration services effective July 1, 2010 through June 30, 2013.

The Health Fund Budgets for FY 2010-11 include appropriations in support of the benefit related contracts listed above.

NOW THEREFORE, the Council directs:


