7. BACKGROUND/ANALYSIS

The ordinance amends the current Contract (C35136) with Aliquant Corporation. The City's online benefit enrollment system complies with the intent of e-government policies adopted by the City Council. Aliquant Corporation was selected through the City's competitive bid process to provide web-based benefit enrollment and IT administrative software services. The term of the agreement ends on June 30, 2010. It is appropriate to extend the contract through June 30, 2013 as provided under City Charter, Chapter 5.22.220. Section D.12 which allows the City to renew existing contracts in order to utilize the pre-existing knowledge of the vendor. Decisions regarding the benefits components of SAP have been deferred. In order to continue these services, it is appropriate to continue the current agreement through June 30, 2013.
