## ORDINANCE No.

\* Amend Intergovernmental Agreement between Portland Development Commission and the Portland Housing Bureau for housing coordination and transition (Ordinance)

The City of Portland ordains:

## SECTION 1. The Council finds

- 1. On July 29, 2009, City Council passed Ordinance No. 183052 which set out the Intergovernmental Agreement between the Portland Development Commission and the Portland Housing Bureau (PHB) for housing coordination and transition.
- 2. This agreement allows for reimbursement of eligible Tax Increment Financing (TIF) expenditures that are incurred by the Portland Housing Bureau, as outlined in Exhibits A and B.
- 3. Exhibits A and B need to be modified to reflect budget allocation by expenditure categories, which will enable reimbursement requests to be processed for TIF eligible expenditures.
- 4. The total amount of TIF reimbursement to PHB remains unchanged.
- 5. All other terms of the Intergovernmental Agreement shall remain the same.

## NOW THEREFORE, The Council directs:

The Director of the Portland Housing Bureau and City Auditor are authorized to sign the Amendment #1 for the Intergovernmental Agreement between the Portland Development Commission and the Portland Housing Bureau for housing coordination and transition.

SECTION 2. The Council declares that an emergency exists because a delay would prevent timely reimbursement of TIF eligible expenditures, which are necessary for PHB to balance its budget.
