# 1) Legislation Title:

\*Accept a grant in the amount of \$311,480 from Metro's Nature in Neighborhoods Capital Grants Program for Crystal Springs Culvert Removal and Habitat Restoration Project (Ordinance)

### 2) Purpose of the Proposed Legislation:

Authorizes the City to accept grant funding that will allow the City to leverage Gray to Green (G2G) land acquisition and culvert replacement funding that is appropriated to this Crystal Springs culvert project (Brannan property).

#### 3) Revenue:

Will this legislation generate or reduce current or future revenue coming to the City? If so, by how much? If new revenue is generated please identify the source.

Passing the ordinance gives BES the opportunity to accept \$311,480 in grant funding from Metro for removal of a fish barrier that blocks juvenile fish passage, daylighting a stream, and restoring floodplain and riparian habitat in Crystal Springs.

The grant from Metro requires a 2:1 match. Local match in the amount of \$664,111 will be provided in the form of salary, benefits, land acquisition, volunteer hours and services in the FY 2009/10 budget and FY 2010/11 proposed budget of the Bureau of Environmental Services. Matching funds are available in the Sewer System Operating Fund, Bureau of Environmental Services, WBS element E09112 and E09119.
