7. BACKGROUND/ANALYSIS:

The 1% for Green program is designed to reduce storm water runoff from the public right-of-way (ROW) from entering into the City's storm water system. The culvert program is designed to remove fish passage barriers that restrict salmon recovery. Both of these programs benefit from the assistance of private property owners and thus make an alternative contracting process desirable rather than using the competitive bidding process.

8. FINANCIAL IMPACT:

Exact figures are unknown until projects are identified and scopes are determined. Over the five year time frame it is not anticipated that the combined contracts total will exceed \$3 million. Funds are available within the FY 2009-2010 Sewer System Operating and Capital Fund and have been requested for FY 2010-2011. Contracts will not be negotiated unless funds are available for future projects.
