## Changes From Previous Versions - Fixed Reference Point -

Previous versions tried to protect and describe a through-passage corridor in the center section of sidewalks that had to change width and lateral position to go around and between permitted and allowed objects. With no fixed reference points possible, there was some uncertainty about corridor boundaries in practice.
A travel zone of standard width measured off the edge of a sidewalk is easy to visualize and measure.

## Changes From Previous Versions

 - Absolute Focus On Uses -Tight focus on managing uses rather than obstruction events further reduces the possibility the code will be characterized as directed at acts of obstruction - a subject preempted by state criminal law.

Changes From Previous Versions - Flexibility To Adjust To Unusual Sidewalk Configurations -

Added authority for Director of the Bureau of Transportation to adjust the standard pedestrian use zone for special situations and to mark zone boundaries.

# Changes From Previous Versions - User Priority - 

Proposed code gives higher priority to needs of sidewalk users with mobility or vision disabilities.
