## ORDINANCE No. 183767

\*Authorize contract with Harper Houf Peterson Righellis to provide design and construction services for the SW Moody Ave Project - SW River Parkway to SW Gibbs. (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. City Council passed Resolution # 36696 on April 8, 2009, adopting the North Macadam Transportation Development Strategy. The SW Moody Avenue project is identified in the North Macadam Transportation Improvements. Based on expected growth in traffic volumes and to accommodate the future Portland to Milwaukie Light Rail project, the City of Portland will reconstruct SW Moody Avenue.
- 2. On October 21, 2009, the Oregon Transportation Commission approved an amendment to the State Transportation Improvement Program that divided the funding for I-5 @ N Macadam between two projects: SW Harbor Dr/SW River Parkway Improvements and SW Moody Avenue: SW River Parkway SW Gibbs Street.
- 3. On February 17, 2010, the City of Portland learned that it would receive \$23,203,988 in TIGER funds for the SW Moody Avenue project.
- 4. On February 25, 2010, the City of Portland received proposals for professional services for engineering and construction services for the SW Moody Avenue project.
- 5. After reviewing the proposals received, Harper Houf Peterson Righellis was selected as the most qualified consultant to complete the work identified.

## NOW THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are hereby authorized to enter into a contract with Harper Houf Peterson Righellis Inc., similar in form to Exhibit A attached to the original of this ordinance, and by reference made a part hereof.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to, Harper Houf Peterson Righellis Inc. chargeable to the Transportation Fund.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily effect the City's ability to perform the required activities; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
