


7. BACKGROUND/ANALYSIS

This Ordinance is to authorize settlement of a claim brought against the City by Stevawn Welch and her husband, Richard McEachran (Risk File Nos. G2010-0159-01 & -02). This settlement is subject to the approval of the City Council. We are recommending the City pay a total of \$60,597.73 to settle the claim.

The incident that led to this claim began on December 11, 2009. A sewage backup heavily damaged the claimants' home and contents at 12022 SE Liebe Street, in Portland. Their property insurer denied coverage for the loss. Investigation by Risk Management, BES, and PBOT's Bureau of Maintenance indicate there is substantial likelihood that the City would be held liable for the damage in this case. Risk Management has therefore advanced \$5,000 for Ms. Welch and \$5,000 for Mr. McEachran for cleanup and preliminary repairs. This is the maximum payable on these claims without an ordinance approving payment of additional amounts.

The proposed Ordinance requests authority for Risk Management to settle both claims, combined, for a total of \$60,597.73 (which includes the \$10,000.00 previously advanced by Risk Management).

8. FINANCIAL IMPACT

Approval of the settlement would result in a payment of \$60,597.73 from the liability fund.

9. RECOMMENDATION/ACTION REQUESTED

Submit the attached Ordinance for approval by City Council as an emergency ordinance.
