

ORDINANCE No. 183777 As Amended

Authorize an Intergovernmental Agreement in the form of a permit from Multnomah County for location of an advanced parking information sign (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In the fall of 2007, the Portland Bureau of Transportation's Keep Portland Moving project, in partnership with SmartPark, undertook a pilot project to provide real-time information about availability of downtown parking spaces. The project leveraged systems in the SmartPark garages that already collected information regarding available spaces.
2. A changeable advanced parking information sign was temporarily located in the parking lot at 530 SW 2nd Avenue owned and operated by Multnomah County, which required an agreement between the City of Portland and Multnomah County in the form of a 90-day temporary permit.
3. The temporary permit, executed under Ordinance 181432, was subsequently extended for an additional 90 days.
4. After evaluating the sign location during the period of the temporary permit, the Bureau of Transportation concluded that the existing location best met the needs of the public, and entered into negotiations with Multnomah County for a permit to retain the sign in its existing location.
5. Multnomah County agreed to issue a permit for use of the location at a rate of \$130 per month, retroactive to May 30, 2008, when the term of the temporary permit expired.
6. The City Attorney's office has approved the draft permit agreement as to form.
7. Ownership of the sign, responsibility for its maintenance, and responsibility for payments to Multnomah County will be transferred from the Keep Portland Moving project to SmartPark upon successful completion of the Multnomah County permit process.
8. The Bureau's level of confidence in the cost estimates for this project is medium, based on having negotiated a price per month with Multnomah County.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are authorized to enter into an Intergovernmental Agreement with Multnomah County, substantially in accordance with the proposed permit,

attached as Exhibit A, to the original of this ordinance and, by reference, made a part hereof.


- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Multnomah County, chargeable to the Transportation Fund 159.
