Authorize the City to apply for grant funding from FishAmerica Foundation to fund culvert removal and riparian habitat enhancement along Crystal Springs in the Johnson Creek Watershed. Approving submittal of this grant application will allow the City to seek funding that will leverage BES' Grey to Green culvert funding.
