Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by CH2M Hill for the completion of design and permitting work for the replacement of the of the Garden Home section of the Fanno Basin wastewater pump station pressure main, Project No. E08293.
- 2. CH2M Hill is providing professional engineering services under Contract No.37100, effective on October 1, 2006 with an amended expiration date of November 29, 2011.
- 3. The estimated cost of this contract amendment is \$45,450. Funds are available in the Sewer System Operating Fund, FY 2010 Budget, Bureau of Environmental Services, Project No. E08293.
- 4. M/W/ESB participation after the authorization of this contract amendment will be \$28,884, 6.02% of the total amended contract amount of \$479,939.

- a. The Commissioner of Public Affairs is authorized to execute an amendment to Contract No. 37100 with CH2M Hill, in a form substantially in accordance with the amendment attached as Exhibit A, for the purpose described in Section 1, in the amount of \$45,450.
