*Amend contract with Global Diving & Salvage, Inc. to increase compensation and increase the scope of work for the Bull Run Dam 1 Outlet Works Improvements Phase 2. Project (Ordinance; amend Contract No. 30000667)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland Water Bureau entered into a contract with Global Diving & Salvage, Inc. for construction services on the Bull Run Dam 1 Outlet Works Improvements, Phase 2, Project.
- 2. The Contractor will install new trash racks, install two stilling wells, and perform extra work required due to differing site conditions. Additional funding is required to pay for these additions.
- 3. The contract will be amended to increase the contract by \$306,515. The new contract total will be \$1,262,765. Funding is available in the FY 2009-10 Budget.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and Auditor are authorized to execute on behalf of the City a change order to Contract No. 30000667 with Global Diving & Salvage, Inc., as outlined in a form substantially in accordance with the change order attached as Exhibit A at a cost not to exceed \$306,515.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because approval of the change order is required to close out the contract. Delay in making final payment may result in interest charges to the City. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
