

ORDINANCE NO. 183875

Amend fee schedule associated with Fire regulations (Ordinance; amend Portland Policy Document FIR-12.01)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Fire & Rescue (PF&R) charges fees for permits, code enforcement inspections, fire reports and miscellaneous services.
2. The Fee Schedule is in Portland Policy Document FIR-12.01.
3. The Bureau of Development Services (BDS) has increased the hourly fee for the Facilities Permit Program (FPP) to \$186 per hour effective July 1, 2010. PF&R partners with the BDS in the FPP program and typically charges the same fee for similar work.
4. PF&R customers frequently request fire report photos in electronic rather than paper form, which is less expensive to produce and warrants a separate fee (\$20.00 per CD) that reflects the lower cost.
5. Portland Policy Document FIR-12.01 adopted by Council in 2008 contained several minor errors and omissions which sometimes cause confusion for customers unfamiliar with PF&R business processes. A better organized, corrected fee schedule will improve customer service, but will not affect the amount customers currently pay for PF&R services.

NOW, THEREFORE, the Council directs:

- A. Fire regulation fee schedule is hereby adopted as shown in Exhibit A and shall be effective July 1, 2010.
