ORDINANCE No. 183885

*Authorize Bureau of Planning and Sustainability to contract with each of six Neighborhood District Coalitions Neighborhood Cleanup Events from 2010 through 2015 at a total cost of \$273,385. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Since 1991, BPS has partnered with Metro to assist Portland Neighborhood Associations with Neighborhood Cleanup events. Generally held in the spring and fall, these events have consisted of weekend depots where residents can bring items for disposal and recycling. In 2008-2009 year, the Neighborhood Cleanup funds served over 6,061 households. Neighborhood Association members and over 1,565 volunteers coordinated 55 neighborhood depots and 28 illegal dumpsites. In addition, volunteers helped 239 senior or handicapped residents dispose of unwanted bulky waste. Neighborhood Associations schedule and run cleanup events with the guidance and assistance of Neighborhood District Coalitions.
- 2. For these cleanup events, BPS provides Neighborhood Associations with financial assistance, helping to fund hauler equipment and labor, promotion and supplies. In addition, BPS staff provides technical assistance to maximize the variety of materials collected for recycling and reuse at each event. Cleanup events are staffed by neighborhood volunteers and utilize community partnerships to expand their efforts.
- 3. Neighborhood Cleanup events fulfill an important role of providing an outlet for residents to properly dispose of household bulky waste, clean up illegal dumping areas and provide assistance to people with disabilities. Over half of the waste collected at Neighborhood Cleanup events is reused or recycled; the remaining half is properly disposed of in a landfill.
- 4. Funds are distributed to Neighborhood District Coalitions who in turn make the funds available to 95 Neighborhood Associations, approximately half of which choose to host a Cleanup event on a given year.
- 5. The Neighborhood District Coalitions are uniquely qualified to provide the desired services in the manner and structure required.
- 6. The established cost is \$273,385. Funds in the current year are available in the Solid Waste Management Fund FY 2009-2010 budget, Bureau of Planning and Sustainability, cost object 9PNSWR000005. Funds are available for the remainder of the contracts.
- 7. The services the Neighborhood District Coalitions provide are important to the City because they provide the volunteer Neighborhood Association system with support and provide a vital link between said associations and City government.

8. Neighborhood Cleanup events are funded partially through Metro's Neighborhood Cleanup Matching Grant Program. On average Metro's grant program makes \$25,000 available to the City of Portland.

NOW, THEREFORE, the Council directs:

a. The Director of Bureau of Planning and Sustainability and Auditor are authorized to execute agreements with each of the six Neighborhood District Coalitions substantially in conformance to the agreement attached as exhibit A for the purposes outlined in Section 1 above and in the following amounts:
