

**RESOLUTION No. 36794**

Approve a Memorandum of Understanding with Multnomah County regarding funding for the Mental Health Crisis Assessment and Treatment Center (Resolution)

WHEREAS, recent events over the past few years involving mentally ill individuals have demonstrated the community's need to strengthen the mental health services provided in Portland; and

WHEREAS, community leaders, mental health advocates and others have long identified the need for a mental health sub-acute facility in our community; and

WHEREAS, the Crisis Assessment and Treatment Center (CATC) will be a 16-bed secure, locked facility in which people will stay from four to fourteen days as their mental health symptoms stabilize; and

WHEREAS, the construction of the CATC has been made possible by funding from the City of Portland, Multnomah County, the Portland Development Commission and the State of Oregon; and

WHEREAS, this investment is a very high priority for City Council and our partners at Multnomah County; and

WHEREAS, by taking this action, construction can begin this summer and the facility can open in 2011; and

WHEREAS, we will create a new community service and put construction crews back to work on the almost \$6 million renovation; and

WHEREAS, the attached Memorandum of Understanding expresses the intent of the City of Portland and Multnomah County to share the cost of operation of the CATC when construction is complete.


NOW, THEREFORE, BE IT RESOLVED the attached Memorandum of Understanding is approved and the Mayor is directed to sign the agreement.
