WHEREAS, upon the 5th.day of May 1882 a petition was filed with R.L. Durham Auditor and Clerk of the City of Portland praying for the vacation of the --hereinafter named Streets in Couch's Addition to the City of Portland to-wit;-

North Sixth Street from the north line of " $J^{**}$  Street to North Front Street.

North Fifth Street from the north line of "I"

Street to North Front Street.

North Fourth Street from the north line of "I"

Street to North Front Street.

North Third Street from the north line of "K" Street to North Front Street.

North Second Street from the north line of "G"

Street to North Front Street.

That portion of "H" Street East of the East line of North Third Street.

That portion of "I" Street East of the East line of North Fourth Street.

That portion of "J" Street East of the East line of North Sixth Street.

Those portions of "K", "L", and "M" Streets Bust of the East line of North Seventh Street.

Which said petition set forth the particular circum-

stances of the case, gave a distinct description of --

the property to be vacated, and the names of the persons to be particularly affected thereby and was duly 133 signed by the parties interested therein.

And whereas due notice was given of the pendency of said petition, and that at a regular meeting of the Common Council of said City of Portland upon the seventh day of June 1882. application would be made by said petitioners for an ordinance of said Common Council declaring said portions of said Streets to-ひざむ!-

papers printed and published in said City, for more than thirty days prior to said seventh day of June.

NOW upon this deventhay of June 1882 at a regular meeting of said Common Council it appearing that the consent of all persons owning property immediately adjoining said portion of said Streets sought to be vacated had been duly obtained thereto in writing and acknowledged as required by law, and it further appear. ing that the said portions of said Streets with the exception of the said portion of Third Street had new er been opened or improved and that it would be for the best interests of all parties conserned to have said portion of said streets vacated and that, no injury would be caused thereby to my person interested

therein, or to the said City or to the public generally, and it further appearing that no objection has --been made or filed theretgand no one has appeared and objected.

The City of Portland does ordain as follows: That all the following enumerated portions of the following enumerated Streets in Couch's Addition to the City of Portland to-wit:-

North Sixth Street from the north line of "J"

Street to North Front Street.

North Fifth Street from the north line of "I"

Street to North Front Street.

North Fourth Street from the north line of "I" Street to North Front Street.

North Third Street from the north line of "H

Street to North Front Street.

North Second Street from the north line of "G"

Street to North Front Street.

That portion of "H" Street East of the East line of North Third Street.

That portion of "I" Street East of the East line of North Fourth Street.

That portion of "J" Street East of the East line

of North Sixth Street Those portions of "K", "L" and "M" Streets East of the East line of North Seventh Street. be and the same to hereby vacated.
