

ORDINANCE NO.7392.

An Ordinance adopting the Report of the City Surveyor in the matter of the proposed lateral extension of Hawthorne Avenue from the Willamette River to East Eleventh street in the City of Portland.

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:

SECTION 1:- Whereas the Common Council deeming it expedient to extend Hawthorne Avenue, from from the west line of East Eleventh street to the established Wharf line of the Willamette River in the City of Portland, did on the 20th day of Jan. 1892, direct the City Surveyor to survey the same mark the boundaries thereof and make his report of such survey containing a plat thereof and a full and perfect description of such proposed street extension and the boundaries thereof and of the portion of each tract or lot or part thereof, to be appropriated to public use for such proposed street extension and the City Surveyor having made such survey report and plat and filed the same in the office of the Auditor and Clerk on the 1st day of February 1892, and said report being satisfactory to the Common Council-

NOW THEREFORE, The ^{said} Report of T.M.Hurlburt City Surveyor in the matter of the proposed lateral extension of Hawthorne Avenue is hereby adopted of which said report the following is a copy, to wit:-

TO THE HONORABLE THE COMMON COUNCIL OF THE CITY OF PORTLAND.

GENTLEMEN:-

In pursuance of a Resolution adopted by your Honorable Body at your meeting of Jan 20th A.D. 1892, directing me to survey and mark the boundaries of a proposed lateral extension of Hawthorne Avenue from the west line of E. 11th street to

the established wharf line of the Willamette River by widening said Avenue 5 feet on each side center and making the side line 35 feet distant from and parallel with the present line of Hawthorne Avenue.

I have surveyed and marked the boundaries of the proposed lateral extension of Hawthorne Avenue and herein submit my report containing a plat of said survey.

The proposed lateral extension of Hawthorne Avenue is ten feet being 5 feet on each side of said Avenue and is more particularly bounded and described as follows, to-wit:-

Beginning at a point in the west line of East Eleventh street 35 feet south from the center line of said Hawthorne Avenue and running thence westerly parallel to and 35 feet southerly from said center line of Hawthorne Avenue to the established wharf line of the Willamette River; thence northerly along the said established wharf line to a point that is 35 feet northerly from when measured at right angles to the center line of Hawthorne Avenue thence easterly parallel to and 35 feet distant from said center line of Hawthorne Avenue to a point where the west line of East Eleventh St. when produced northerly in its present course will intersect thence southerly 70 feet to place of beginning.

The proposed lateral extension of Hawthorne Avenue will include and necessitate the appropriation to public use for such Avenue the following described parcels or tracts of land, to-wit;

All that parcel or tract of land lying between the north line of Hawthorne Avenue and the north line of the proposed lateral extension thereof and bounded on the east by a northerly extension of the west line of East 11th street and bounded on the west by the east line of East 9th street containing twenty three hundred (2300) square feet and owned by Mrs. Hawthorne.

ORDINANCE NO. 7398.

An Ordinance adopting the report of the City Surveyor in the matter of the proposed extension of Twenty Fourth street from the south line of Vaughn (formerly "W") street to the north line of Thurman (formerly "T") street in Wilson's Addition to the City of Portland.

THE CITY OF PORTLAND DOCS ORDAIN AS FOLLOWS:

SECTION 1:- Whereas the Common Council deeming it expedient to extend, open lay out and establish Twenty Fourth street in Wilson's Addition to the City of Portland, from the south line of Vaughn formerly "W" street to the north line of Thurman (formerly "T") street did on the 20th day of January 1892, direct the City Surveyor to survey the same, mark the boundaries thereof and make his report of such survey, containing a plat thereof and a full and perfect description of such proposed street extension and the boundaries thereof and of the portion of each tract, or lot or part thereof to be appropriated to public use for such proposed street extension and the City Surveyor having made such survey report and plat and filed the same in the office of the Auditor and Clerk on the 1st day of February 1892 and said report being satisfactory to the Common Council,

NOW THEREFORE, The said report of T.M.Hurlburt City Surveyor, in the matter of the proposed extension of Twenty Fourth street is hereby adopted of which said report the following is a copy to-wit:-

TO THE HONORABLE THE COMMON COUNCIL OF THE CITY OF PORTLAND.

Gentlemen:-

In pursuance of a resolution adopted by your Honorable Body at your meeting of January the 20th A.D. 1892, directing me to survey and mark the boundaries of the proposed extension of 24th street in Wilson's Addition to the City of Portland, from the south line of Vaughn (formerly "W") street to the north line of Thurman (formerly "T") street.

I have surveyed and marked the boundaries of the proposed extension of 24th street and herein submit my report containing a plat of said survey.

The proposed extension of 24th street is 60 feet in width and is more particularly bounded and described as follows, to-wit:-

Beginning at a point in the south line of Vaughn street where the west line of 24th street produced northerly in its present course will intersect thence southerly along said west line of 24th street to the north line of Thurman street; thence easterly along said north line of Thurman street 60 feet to a point where the east line of 24th street produced southerly in its present course will intersect; thence northerly along said east line of 24th street to the south line of Vaughn street; thence westerly along said south line of Vaughn street 60 feet to place of beginning.

The proposed extension of 24th street will include and necessitate the appropriation to public use for such street the following described parcels or tracts of land, to-wit;

All that parcel or tract of land lying between the east and west lines of the proposed extension of 24th street and bounded on the north by the south line of Vaughn street and on the south by a line five feet southerly from and parallel to the north line of Wilson's Addition containing one hundred and thirty two (132) square feet, owner unknown.

Also all that parcel or tract of land lying between the east and west lines of the proposed extension of 24th street and bounded on the south by the north line of Thurman street and on the north by the south line of Wilson's Addition containing eight hundred and eighty eight (888)
